

## Walmart FLW Tour on the Red River presented by OFF! – Can-Am ATV Giveaway

If, for any reason, the FLW Outdoors Expo is cancelled and not rescheduled the prize will be void and eliminated from this Promotion.
3. **DETERMINATION OF WINNER AND PRIZE:**

**MUST BE PRESENT TO WIN.** An Outlander 500XT Camo Can-Am ATV (Approximate Retail Value \$9,699) will be awarded to the Entrant who is present and whose name is drawn in a random drawing following the May 22, 2011 4 p.m. CT weigh-in taking place at the Shreveport Convention Center located at 400 Caddo Street in Shreveport, La. Odds of winning will be determined by the number of eligible entries received and number of entrants present at the time of the drawing.
